9. Closing Thanksgiving and Prayer

Minutes of the Meeting of Parishioners held on Sunday 15th May 2022 at 10:00 am in ECN

Present in person: Rev. Tim Meathrel (Chairman) and approximately 90 members on the Electoral Roll were present in the church, as well as their family members and a considerable number of other attendees.

1. Appointment of clerk to the meeting

The Chairman explained that it was usual for the PCC Secretary to be proposed as the clerk to the meeting. Accordingly he asked if Tim Warren should be invited to act as such clerk. The formal appointment was proposed by Colin Sheppard and seconded by Geoff Gale. There were no other nominations and Tim Warren was thus appointed.

2. Apologies

Apologies for absence had been received from a number of members. Their names were read by the Clerk.

3. Minutes of the meeting of Parishioners on 25th April 2021

No questions or comments had been received and there were none from the floor. A resolution as to the approval of the Minutes was put by the Chairman (proposed Josh Tate, seconded by Sarah Groves) and the parishioners present indicated their unanimous approval of the minutes.

4. Election of two Churchwardens

Tim Meathrel thanked Sarah Groves and Giles Denham for their hard work, advice and support provided as the 2 church wardens. Both were happy to continue for another year, they were both eligible to continue and their nominations were the only ones received. They were declared duly elected and Tim prayed for them in the fulfilment of their responsibilities.

Closure of the meeting

The meeting was declared closed.

Minutes of the Annual Parochial Church Meeting held on Sunday 15th May 2022 in the Church at approximately 10.30am following the Meeting of Parishioners (as to which see separate minutes).

Present in person: Rev. Tim Meathrel (Chairman) and approximately 90 members on the Electoral Roll were present in the church, as well as their family members and a considerable number of other attendees.

1. Apologies

These were taken as the same as the names read in the Parishioners' meeting.

2. Minutes of the APCM held on 25th April 2021

Tim Meathrel said the minutes had been available prior to the meeting in the meeting booklet. Tim Warren confirmed he had received no questions or comments prior to the meeting. Tim Meathrel invited members present if there were any questions but there were none.

A resolution to accept the minutes as an accurate record of the previous meeting was put to the meeting (proposed by Giles Denham, seconded by Clive Backhouse) and was agreed unanimously.

2. Matters Arising

There were no matters arising either before the meeting or from the floor.

3. Election of Representatives to the Parochial Church Council

Tim Meathrel thanked each of those who were retiring from the PCC, Judith Cox, Nicola Davis (who was standing again) and Kay Sadler. Members of the PCC were invited to come forward and to be thanked by those present for the contributions of each. There were 6 available places for elected members of the PCC, but only 5 nominations.

The 5 nominated people were declared duly elected, for 3 years in each case. They are Emmanuel Nnatuanya, Catherine Brewer, Colin Sheppard, Nicola Davis & Michael Davey.

Tim M thanked all who had stood and prayed for them.

5. Adoption of the Report on the Proceedings of the Parochial Church Council and Financial Statements for the Year ended 31st December 2021

Chris Daykin (Treasurer) presented his report to the meeting. He used Powerpoint slides in his presentation. He said the full Financial Statements were not in the Booklet but if someone wished to see them and they had not been posted on the website within the next day or so, any member of the Finance Team would be happy to supply a copy on request.

There had been a small surplus for Emmanuel Central (ie excluding Eastbury) of £11K in 2021. This was rather better than expected, because we hadn't spent as much as had been budgeted.

Regular giving and tax recoveries had fallen a little, but other income and the generosity of the 2020 Gift Day had carried us through.

In 2021 we had given away £110K, including £76K for overseas mission, £32K for UK based mission and £2K from the Compassion Fund

There was a shortfall in the Eastbury Account of £12,500 for 2021.

Chris turned to the question of our expectations for 2022. A deficit of £30k had been projected and approved by the PCC, which included carry forward of £26,000 from 2021 of spending to revamp the church fire alarm system. In addition we would need to raise about £135,000 for the church roof and brickwork project. Chris had included some slides in the presentation showing the damage to the tiles on the roof and the brickwork. This essential work would be done in the autumn of 2022. He said that one way or another we would have to pay for it.

Chris then thanked the Finance Team including

- Lynette Leach Emmanuel's book-keeper
- Margaret Dolling Donations Treasurer
- Peng Lim Eastbury Treasurer
- Other members of the Finance Committee, Sarah Altman, Nicola Davis, Giles Denham, Sarah Groves and Tim Meathrel

Let us give God the glory for His provision for our financial needs and trust him to provide in 2022.

In concluding Chris reminded us of 2 verses "For you know the grace of our Lord Jesus Christ, that though he was rich, yet for your sakes he became poor, so that through his poverty you might become rich (2 Corinthians 8 v 9) and "Bring the whole tithe into the storehouse...and see if I will not throw open the floodgates of heaven and pour out so much blessing" (Mal 3 v 10).

Adoption of report and accounts

Proposed Resolution adopted unanimously:

That the Annual Report and Financial Statements for 2022 be adopted (proposed by Brian Cox, Seconded by Maria Perkes

The Annual Report and Financial Statements were thus adopted.

Appointment of Independent Examiner

Following a recommendation from the Finance Committee accordingly, *the following resolution was put and agreed unanimously:*

That Munday Long be appointed as the independent examiner for Emmanuel Church PCC for the year 2023 and that the PCC be authorised to agree their remuneration (proposed by Giles Denham, seconded by Jon Whitmarsh)

Tim M thanked Chris Daykin for his report and Margaret Dolling for her hard work as the Donations Treasurer. The Finance team was also thanked on behalf of the whole church.

6. Reports of the Electoral Roll Officer, Report on the Fabric, Goods and Ornaments of the Church, Harrow Deanery Synod Report and Safeguarding Officer's Report.

The above reports were all included in the booklet prepared for the APCM. Tim Meathrel said it was his proposal that all the reports should be taken as read and accepted together. No-one objected and the reports were thus accepted nem con.

An opportunity for questions was given. There were none. There had been no prior questions or comments.

Tim M took the opportunity to thank on behalf of the church those involved in the committees providing these reports, and in addition the Eastbury Subgroup-Outreach group, the eco church group and the various assistant wardens for their roles at each of the 3 main Sunday services, as well as others serving in a number of ways.

7. Vicar's Report Address by The Revd Tim Meathrel Numbers 13 1-2 and 26-33

Tim M spoke on the passage read by Colin Sheppard

Moses has led the people of Israel out of slavery in Egypt, through the Red Sea right to the edge of the promised land. The land that God had promised to Abraham many years before. In Numbers 13 we find God's people standing at the edge of the land, at the edge of the promises of God and at the edge of their destiny and purpose. God tells Moses to choose 12 men to explore the land who would be representatives from each of the tribes of Israel. Moses sends them out with two key questions in mind. what God's people really want to know is:

- 1. 'what does our future look like?'
- 2. 'How hard is it going to be to get there?'

As God's people were looking to their future they were in a season of excitement but also anxiety. They were on the edge of something different and new but they were scared of how hard it might be to get there. So the spies travel across the land and they come back to report. Which is where the tragedy beings. Instead of this being a story of triumph they listen to the voice of fear. The 10 spies don't deny the reality of the goodness of the land, they're objective in describing the land 'flowing with milk and honey' = a picture of the fruitfulness of the land. But they also report that they've seen descendants of Anak (In Israelite tradition – means Giant Warriors) and are filled with fear. Only Caleb and Joshua bring back a faith-filled response.

What was different about Caleb & Joshua

1. They had a different perspective

Their report was full of faith and not fear. The other 10 spies saw the size of the task and gave in to fear but Caleb & Joshua had a different perspective. Not that they didn't see the challenges. They weren't oblivious to the difficulties that lay ahead. They too had seen the fortified cities and the large and powerful people that lived in the land. They didn't dispute the report of their colleagues BUT they had a different spirit and they had a different perspective. They didn't ignore the obstacles, they just knew that they had a God who was bigger than the obstacles.

We face lots of challenges too. Financing the building work is one. Perhaps more significantly, how can we help people to get to know Jesus in this area? We face cultural challenges too: living in a pluralistic society, post-Christian society, post-truth society, anti-establishment, culture moving rapidly away from traditional Christian values and ethics. How can we be a relevant, gospel centred community in this society?

That's why we believe that God has spoken to us about vision. A vision to see God's kingdom come in Northwood, our city, nation and world through a call for us to be growing deeper, younger and wider. Still believe that this is an audacious vision and a challenging vision in our context.

Faced with challenges, it's all too easy to look at those challenges and lose heart. To think it's too big, too difficult. But Caleb & Joshua encourage us in the face of challenges that 'we can certainly do it!' Faith isn't ignoring the obstacles we face it's knowing that we've got a God who is bigger than any obstacles we face. Caleb & Joshua had a bigger perspective, they had a greater trust and their vision was full of God, full of faith and not fear. The other 10 were rooted in a place of fear. Struggling to see how God could act. Struggling to imagine how God could intervene and be sovereign and in control. Struggling to trust in God's word.

So what's our perspective? Is it full of faith or full of fear?

2. Their faith was rooted in what God had already done

This didn't happen in a vacuum. The people of God didn't just appear at the edge of the promised land from nowhere. They had a back story and had been on a journey with God. They'd seen their God win the power struggle over the gods of Egypt. They'd seen God intervene miraculously at the Red Sea, destroying the mighty Egyptian army. They'd seen the pillars of cloud and fire which God used to guide them. They'd seen God act before and that gave them faith to believe that God can act in the future.

The same is true for us too! We've been journeying with God to and we have so much to thank God for. Remembering what God has done and giving thanks to him releases faith in us for God to act again. As we rebuild after Covid I truly believe, to borrow Boris' phrase, we're building back better!

We're seeing our vision of Deeper, Younger, Wider come alive

- As new people join from all different backgrounds
- As more children and young people connect with us as church Sundays, Childrens
 & Youth activities
- As more people are cared for Dave & Pastoral Team
- As we feed the hungry Foodbank ministry (2-3 to 41), Food on Friday
- As we see faith deepening in so many people's lives Sunday services, midweek groups etc
- Sundays so key, massive impact by going online (still well over 100 views each week), tech team, worship team, readers, prayers, prayer ministry team – those who lead & preach – especially our LLM Martyn & Mairi
- As we restore our welcome and hospitality ministries
- As we connect more with our local schools Lionheart Club, Easter Holiday club, assemblies & lessons, Christine & Nina as governors at Hillside Infant and Juniors, relationships with other local schools
- As we continue to serve our community in so many different ways Toddlers, ELC,
 Communication Café, Wednesday Fellowship, coffee mornings, special events in our community eg Remembrance services
 - As people come to faith for the first time through things like Alpha

None of this would be possible if we didn't do it together. There are too many people to thank. We want to say a massive thank you to everyone who serves in the life of this church. We are beginning to see our vision become a reality because of all of your hard work, commitment, love and care. THANK YOU!

Thanked our Wardens, PCC & Finance Team – who have done such amazing work. Thanks to staff team. We are so grateful to God for his provision of such an amazing group of talented people. Special thanks to Kate.

8. AOB

One item of AOB had been notified from Stephen Hall. He was invited to address the meeting.

He said that the 2020 Church of England representation rules introduced an automatic two-term limit for the number of terms a parish representative may serve on a deanery synod. Following consultation, in 2022, the Church of England have revised their position and instead adopted a model that allows churches to set their own limits for representation on deanery synods at APCMs.

He said he proposed that we retain the current status quo, asking the APCM to adopt a limit of two consecutive terms for our deanery synod representatives. This maintains the approach we currently have, ensuring we stay consistent with our approach for PCC representation and recognising that church representatives need to take well-earned breaks, as well as providing opportunities to welcome new voices onto our committee.

John Dolling spoke against the proposal, as he did not think ECN would have a problem if the 'opt out' was not taken. He said that discussions were continuing at Diocesan level on

the rule. A resolution was put to the meeting "that a person who, on behalf of Emmanuel Church Northwood, serves as a parochial representative of the laity on the deanery synod for a whole or any part of each of two successive terms of office, with terms starting before 2020 not being taken into account, may not be nominated for election to serve as such for the whole or any part of the term of office immediately following the second of those terms." (proposed by Stephen Hall, seconded by Ben Pearkes). The resolution was duly passed. (67 in favour, 5 against and 17 abstentions)

Giles Denham was invited to say a few words. Giles said had found it a huge privilege to have worked this last year with Tim M and referred to his leadership in the face of the pandemic, when difficult and resolute decisions had been needed. We had been able to meet more than most churches and this had been managed safely in community. It was great to see new people too. Giles brought us a verse from 2 Timothy (Chap 1 vs 7) – 'For the Spirit God gives us does not make us timid, but gives us power, love and self-discipline' – and then referred to the commission in 2 Timothy chapter 4 – 'I charge you in the presence of God and Christ Jesusto preach the Word, be urgent in season, convince rebuke and exhort, be unfailing in patience and in teaching...."

Sarah Groves then spoke, thanking Tim and Kate Meathrel for their ministry. She said we were indeed blessed to have them at ECN. Thistle Garmonsway prayed in closing.

Introductory Background

Emmanuel Church Northwood is an Anglican evangelical church situated at the top of the High Street and has served the Parish for over 100 years. During 2022, there was a church plant, Eastbury Church, that serves the northwest part of the Parish. From the start of 2023, Eastbury Church has discontinued its Sunday services.

Rev. Tim Meathrel has been our Vicar since 5 September 2017. Rev. Dave Scott was licensed as our Associate Vicar on 4 September 2018. The Rev Christine Britton joined us as a curate in July 2020. Her curacy has been extended by agreement with the Diocese until June 2024, as it would be disrupting to her family to move before then. The Rev Nina Oskarsdottir joined us in January 2021 as an Associate Vicar with particular responsibility for pioneering evangelism and Eastbury Church.

The PCC of Emmanuel is a corporate body established by the Church of England. The PCC operates under the Parochial Church Council Powers Measure. The PCC has the responsibility of co-operating with the incumbent in promoting the Gospel of our Lord Jesus Christ according to the doctrines and practices of the Church of England and the whole mission of the Church, Pastoral, Evangelistic, Social and Ecumenical. It also has maintenance responsibilities for all relevant Church property.

The PCC is registered with the Charity Commission as a charity under number 1132091.

The PCC has regard, in relation to its activities, to the Charity Commission's guidance on public benefit and, in particular, the specific guidance on charities for the advancement of religion. Emmanuel provides a public benefit through the activities that are undertaken in pursuance of our aims and objectives. There are a large variety and number of different ministries of Emmanuel, amongst children, young people and adults, whether they are people within our Church community, in the wider community in the Parish or overseas.

In the opening months of 2022, many of the restrictions previously applicable because of the Global Covid pandemic were relaxed and all were removed on 1st April 2022 Although Covid viruses remain, the risk of serious illness, except amongst those who are both unvaccinated and vulnerable, seems to be reduced. However, we continue to be conscious that in person meetings could assist the spread of Covid and other infectious diseases and therefore offer Zoom access to in person meetings where practical. Live streaming of some services is done too. Communion continues to be served by intinction.

Objectives and Activities

It is worth repeating again the summary of our church vision, launched in 2019, at the start of a new chapter in the life and work of Emmanuel.

We are a church of missional disciples seeking to love God and love each other; influencing our community, city, nation and world with the love of Jesus that we might see His Kingdom come.

We believe that God is calling us to be...

- committed to the Word, the Spirit, prayer and worship
- a church for our local community; focused on loving, serving and winning those who don't yet know Jesus
- missional disciples who are bold and courageous, unafraid to take risks and step out in faith
- willing to follow God's leading and direction and to pay the price of being obedient to his call in the use of ourselves, our time and our resources

To do this we believe that God is calling us to grow deeper, grow younger and grow wider.

Growing deeper...

in our relationship with God and in our relationship with each other. Maintaining the priorities of worship, prayer, Bible teaching and openness to the work of the Holy Spirit.

Growing younger...

facing the challenge of declining attendance of under 40s in the UK, we are committed to placing a special emphasis on trying to reach children, young people and their families.

Growing wider...

in mission and evangelism. Growing as missional disciples taking the good news of Jesus and his love and kingdom wherever we go throughout the week. Growing in our outreach as a church seeking to love and serve the people who live and work in Northwood.

2022 was a year of emergence from the global Covid 19 pandemic. Emmanuel and Eastbury Church continued to facilitate worship and give glory to God, to give opportunity for members to encourage and help each other and to bear witness to the resurrection of Jesus Christ.

Thus the following activities have re-opened in person (or partially on line):

- regular public worship open to all on Sundays see below for details
- the provision of sacred space for personal prayer and contemplation
- pastoral work, including support for the sick, the bereaved and the lonely
- the teaching of Christianity through sermons, courses and small groups
- the taking of religious assemblies in schools and an after-school club at Eastbury School
- the provision of children's work
- the provision of age-related youth meetings with a Christian ethos
- the promotion of Christianity through the staging of events and meetings
- the making available of the premises for social justice projects, including a food bank, community lunches and other community purposes
- supporting other Christian mission in the UK and overseas
- promoting the whole mission of the Church

Regular Services

During 2022, there have been 3 Sunday services at Emmanuel and a single Sunday service at Eastbury School. The service at 9am has been 'traditional worship', at 10.30am 'family worship' and at 5.30pm 'contemporary worship'. As mentioned above, it was decided to discontinue the Eastbury Sunday service with effect from the end of 2022. Since August 2021, Eastbury and Emmanuel churches have enjoyed fellowship together at services on the mornings of the first Sunday of each month.

The story of the PCC year is recounted in the PCC Report below.

Achievements and Performance

PCC Report – the Story of the PCC Year 2022

The year 2022 was the year when almost all of the Covid restrictions were removed. The first two meetings were held virtually, but in March we met face to face in the Lounge.

The first meeting was on 17th January 2022. Christine Britton, in our devotional time at the beginning of the meeting, spoke of Martin Luther King's 'I have a dream' speech and challenged members – what is God asking us to dream, what is God stirring us to believe and do? Then it was on to business – agreeing a review of how the revised service pattern was working, the review having been deferred because of the Covid restrictions, considering the risk committee and pastoral care reports and starting to think about the property works required.

Apart from the usual February business of considering the 2021 Accounts and other elements around these, we had the opportunity at this meeting to hear from and greet Sam Bailey, who had been appointed to join us as our new children's minister. We heard of his experience and call to this work amongst us.

We held the March meeting in the Lounge, with Neil Altman (surveyor and chair of the Property Committee) in attendance. The main item of business was around the suggested roof and brickwork works to the building, the necessity for these and/or the wisdom of doing more than was immediately required to save cost in the future and how funds could be raised for the project. It was agreed to ask the Property Committee to move forward with the minimum required, with a view to enlarging the contract if funds became available for the other items that could sensibly be done at the same time. Reports from Eastbury and the 3rd Age ministries were also received and considered.

By April we had a detailed Property Committee paper with recommendations to consider (containing more works and therefore expense than previously authorized) and resolved to back the committee's proposals, and to go to the church for £135K to cover the cost.

After the APCM on 15th May, we had a few changes to the PCC. The meeting on 23rd May dealt with the appointment of officers as usual. By then what was described as an 'avalanche of money' had arrived for the building project, about £110,000 including tax recoveries, with

pledges that took us very close to the target. It was agreed that the formal building contract should be signed.

By June the total giving for the building project had come to £164,000 approximately, so less of the church's reserves would need to be used. The work was also about to start. The PCC also began to consider at what level the Common Fund offer for 2023 should be set. Our annual safeguarding training session was also given by the indefatigable Gill Denham, whose contribution to this vital element of the church's ministry cannot be overestimated.

We met next in September. We heard from Keren Pollock (Chair, International Mission Committee) with the committee's report. In particular she said that the face of international mission is changing and invited the PCC to consider whether, as funds become available from mission partners' retirements, we might wish to redirect the funds saved into different types of outreach ministry – ie where are the mission priorities today?

The idea of reviewing 'outside' giving was picked up in the main agenda item in our October meeting. We divided into small groups and a large amount of feedback with comments and ideas was provided – for distillation by the Vicar, who agreed to consider it all going forward. We also welcomed Matt Bird to the meeting for his worship leader's and technology report.

In November the main item was over the shape of our community outreach, and we heard how the Babies and Toddlers continued to thrive, the English language café was fulfilling a real need, Foodbank was serving more and more people, and there were encouraging connections being built with local schools and with the Base and the Patch. As part of this the PCC discussed the sustainability of Sunday services at Eastbury School and accepted after prayerful consideration that these should be replaced by a mid-week meeting at Nina Oskarsdottir's house in Rofant Road.

Often at the start of a meeting, an opportunity was given to members to share recent experiences of God blessing ministries at Emmanuel. There were always many items mentioned. It's not difficult to see God's hand in the very many activities that took place in 2022 – He really does answer prayer and blessed us to overflowing in 2022.

And finally a verse from Philippians 4 and the April 2022 minutes "Do not be anxious about anything, but in every situation, by prayer and petition, with thanksgiving, present your requests to God. And the peace of God, which transcends all understanding, will guard your hearts and your minds in Jesus Christ."

Statistics

The Diocese requires a 'Statistics for Mission Return' annually. For the year 2020 and going forward the Statistics provided in the Annual Report are those collected for the Return. The charts for the years prior to 2020 will be phased out therefore over the next couple of years. The text for the previous year (2021) is included.

2020 - relating to Emmanuel Church and Eastbury

The 'Statistics for Mission Return' requires details of the numbers attending church in October each year. Special forms were provided for this pandemic year. The figures below are taken from the forms submitted.

On 4th October 2020 103 adults and 20 children/young people attended 3 services in the Emmanuel Church building and 32 adults attended 1 service at Eastbury.

On 11th October 2020 115 adults and 23 children/young people attended 3 services in the Church building and 28 adults and 1 child attended 1 service at Eastbury.

On 18th October 2020 19 adults and 0 children attended 1 service in the Church building. There was no service at Eastbury.

On 25th October 2020 82 adults and 19 children attended 3 services in the Church building and 35 adults attended 1 service at Eastbury.

In addition in October 2020, services were pre-recorded and/or live streamed — called 'Church at Home' by the Diocese. The best estimate of the usual number of people participating in these online services for Emmanuel Church each week in October was 232, excluding those who had attended services in person. The figure for Eastbury was 32.

2021 - relating to Emmanuel Church and Eastbury

On 3rd October 2021 211 adults and 26 children/young people attended 3 services in the Emmanuel Church building. There was no service at Eastbury Church, as on the 1st Sunday of the month Eastbury and Emmanuel join together for worship.

On 10th October 2021 202 adults and 36 children/young people attended 3 services in the Church building and 27 adults attended 1 service at Eastbury.

On 17th October 2021 195 adults and 34 children attended 3 service in the Church building and 22 adults attended 1 service at Eastbury.

On 24th October 2021 149 adults and 22 children attended 3 services in the Church building and 24 adults attended 1 service at Eastbury.

In addition certain services were pre-recorded and/or live streamed. The best estimate of the usual number of people participating in these online services for Emmanuel Church each week in October was 278, excluding those who had attended services in person. The figure for Eastbury was 30.

2022 - relating to Emmanuel Church and Eastbury

On 2nd October 2022 230 adults and 68 children/young people attended 3 services in the Emmanuel Church building.

On 9th October 2022 222 adults and 74 children/young people attended 3 services in the Church building.

On 16th October 2022 260 adults and 74 children attended 3 services in the Church building. On 23rd October 2022 165 adults and 34 children attended 3 services in the Church building.

Structure, Governance and Management

PCC Membership Structure

The full membership of the PCC comprises, ex-officio, the Vicar, the other clergy, the Churchwardens, all Synod representatives and (if they wish to participate) a licensed lay minister, plus up to fifteen elected members of Emmanuel, as well as optional co-opted members. Appointment is governed by, and set out in, the Church Representation Rules. All on the electoral roll may stand for election to the PCC, and elected members may serve up to two consecutive three year terms or a total of six years continuously. Retiring members can be re-nominated after one year. Co-opted members serve up to the next APCM but can be co-opted again to the next PCC if required. The PCC is elected at an Annual Parochial Church Meeting (APCM), usually held in April or May at Emmanuel. In 2022 the APCM was held on 15th May. PCC members may not be employees of the PCC unless the Charity Commission gives permission. There were none. The PCC met 9 times during the year.

PCC Committees

The work of the PCC is divided between Committees whose Chairs are appointed by the PCC at the first meeting after the APCM. The Chairs are normally, but not necessarily, members of the PCC. Members of the Committees do not need to be members of the PCC and a distribution of responsibilities to the wider congregation is encouraged.

Standing Committee

This committee has been delegated the power to transact the business of the PCC between PCC meetings, subject to any directions given by the PCC. It must consist of the Incumbent (or Associate Vicar) and Wardens and at least two members of the PCC. In addition to the Incumbent and Wardens the following PCC members served on the Standing Committee during 2022. Jon Whitmarsh (Operations Manager) is in attendance at the meetings 'ex officio'.

A meeting of the PCC was held on 23rd May 2022. At this meeting the officers (as set out above) and the Rev Dave Scott were re-appointed. Following that meeting a vote was held and Mrs Deirin Johnson and Mr Josh Tate were re-elected to serve on the Standing Committee.

Finance Committee

The Finance Committee oversees the finances of Emmanuel. It monitors income and expenditure, recommends budgets to the PCC, maintains appropriate financial controls and co-ordinates reviews of Christian stewardship and encouragement of efficient planned giving. The Chair during the year was Mr Chris Daykin, who was also the Hon. Church Treasurer.

Personnel Committee

The Personnel Committee acts as an advisory body to the PCC on the appointment and remuneration of non-clerical staff. The Chair during the year was Mrs Mirka Packard.

Property Committee

The Property Committee works to ensure that church buildings, fabric and ornaments remain in good order. The Chair during the year was Mr Neil Altman. A formal report to the APCM is delivered each year.

As well as overseeing the maintenance of the Church buildings the Property Committee oversees the following properties owned by the PCC:

- A. 64 Chester Road occupied by Rev Christine Britton and her family since December 2020
- B. 4 Church Close occupied by Rev Dave Scott (Associate Vicar) and his family since 2018
- C. Flat 6 Beeches House, High Street currently rented out on a commercial basis.

Apart from routine maintenance, major works were carried out during the year to the fabric of the church building, involving the replacement of the tiles on the north side of the roof, replacing a large number of bricks in the structure of the building with associated re-pointing, the repair and renewals of the guttering, and the replacement of cracked or broken panes of glass in the windows.

All gas safety certificates needed have been obtained and renewed.

Risk Committee

The Risk Committee is in place to ensure Emmanuel is addressing its risks appropriately. The Chair during the year was Mr Ben Pearkes.

The risks to the church are divided into 8 'baskets': Finance, Safeguarding for Children and Vulnerable Adults, Key Compliance, Health and Safety, IT & Data, Staffing Matters, Strategic Planning and Volunteers.

The committee meets at least two times a year and works through each of the risk baskets at least once every 18 months. The risk basket holder is invited for that specific meeting. At all meetings there is also the opportunity to raise 'arising risks' which are reviewed and evaluated.

The current Risk Profile shows that there is one identified **High** risk (related to safeguarding) and 12 identified **Medium** risks, including but not limited to, the possibility of a financial deficit for urgent expensive repairs to our buildings, loss of key volunteers and food safety failings. The 26 remaining risks are classified as **Low** risks.

During the meetings, the Risk Committee challenge the risk basket holder to identify any changes to the current scoring (increasing or decreasing the current risk to the

church) and discuss new and current mitigation to confirm the risk is being addressed appropriately. An action list is created which is followed up at subsequent meetings.

International Mission Committee

ECN is privileged to support many Mission Partners across the world. The IMC's mission strategy compiled in line with the vision statement to help shape and direct the way forward for ECN's involvement in global mission is:

- To ensure that the teaching and interaction with Mission Partners regularly informs, trains and equips the congregation on the significance of the Biblical mandate for global cross-cultural mission to reach the 'least reached' peoples of the world;
- 2. To work closely with Mission Partners to resource, train and inform our congregation;
- **3.** To encourage Mission Partners and Associate Partners through prayer, visits and support on a monthly basis;
- **4.** To encourage many more from the church, in particular the youth and young adult groups, to engage in mission through facilitating more short-term mission trips;
- **5.** To actively seek, coach and mentor those from within our congregation who may be called to full-time mission;
- **6.** To incorporate and encourage individual and corporate prayer for global cross-cultural mission.

Review of 2022

2022 saw a gradual move back to pre-Covid times. We have been able to incorporate some of the best practices developed during the pandemic, such as use of Zoom to keep in touch with our Mission Partners. Towards the latter part of the year we were able to welcome some Partners in person to the services as well as resuming hosting events.

- The Committee met bi-monthly to plan events and manage all aspects of support for our Mission Partners. At our first meeting of 2022, Tim and Sung-Hee joined us by Zoom and helpfully led us in thinking about the challenge of mission in today's world.
- Jean Nunney continues very helpfully to compile the Mission Partners' monthly news updates. All our Partners express how much they appreciate keeping regularly in touch and with each other through the monthly prayer news.
- Where possible and where it is safe to do so, our Mission Partners were back on the screen before services when they are MP of the month. They also took part in the monthly prayer meeting by Zoom or in person where possible.
- We resumed hosting events when possible: a retirement party for over 100 guests for Tim and Sung-Hee; 'Tea with Jeremy' and ECN was the venue for the annual training conference for Mission Africa.
- In July, the Committee submitted a paper on the IMC Budget to the PCC for discussion.

- Our annual World Wide Weekend was held in November. Our speakers were
 Graham Archer from CPAS and Josh Tate speaking on mission through ECO Church.
- As the world opens up we are continuing to explore the possibility of mission trips both at home and abroad. We have been in discussion with Steve and Sandie about the numerous opportunities offered through OM.

Updates on our Missions Partners (financially supported) and Associate Missions Partners (receive prayer support and occasional financial gifts as required).

- Tim and Sung-Hee officially retired in September and we had a joyful, well-attended service of celebration for their years of service with Interserve. Very sadly, Tim became seriously unwell very shortly after this. It is remarkable what he has come through but he remains in hospital. Sung-Hee has been equally remarkable in her faith and testimony to all the staff and other patients in the hospital. The policy of the IMC is to give half the annual contribution to retiring MPs to support them as they adjust to retirement. Tim and Sung-Hee are therefore receiving this support.
- David Morgan also retired in 2022. We continue to support Sharon, at a reduced rate, as she continues her essential work with Wycliffe.
- X&Y have moved house which enables them to offer hospitality to locals much more easily. The IMC was able to give a financial gift to support this move.
- We were able to offer some financial and pastoral support to one of our Associate Partners who has experienced significant struggles this year.
- The IMC is in discussion and prayer about two new exciting developments. We have been approached by a couple well-known to ECN to be considered as Associate Mission Partners. One of our current Associate Mission Partners is being called to a full-time and new role and would like now to be considered as a full Mission Partner.

Following the 2022 APCM Mr Ben Pearkes was re-elected by the PCC as Hon Vice-Chairman (Lay Chair) of the PCC, Mr Chris Daykin (having been co-opted to the PCC) was re-elected to the post of Hon. Treasurer and Mr Tim Warren was re-elected as Hon. PCC Secretary.

Reserves Policy

Total unrestricted reserves as at 31 December 2022 amounted to £2,046,200 (2021: £2,057,300). This included fixed assets (property) with a net book value of £1,850,000 (2021: £1,835,000), leaving free liquid reserves of £211,200 (2021: £222,300). Of these free reserves £91,800 (2021: £96,500) has been designated towards specific areas of the Church's work. The PCC's policy is to hold only sufficient reserves to enable it to meet outgoings on a day-to-day basis, relying on the faithfulness of God to provide for our financial needs at Emmanuel, as He has done for more than 100 years. It is the aim of the PCC to hold reserves equivalent to three months of unrestricted outgoings.

FINANCIAL REVIEW OF 2022

The year 2022 saw a full year after the Covid-19 pandemic, with all activities returning to normal. A Giving Day held in February resulted in some increases in regular giving and some one-off gifts. As a result our giving for the year was well above budget. With rapid increases in the cost of living and fuel costs in particular, we raised rental charges from September and saw a material increase in the income from that source.

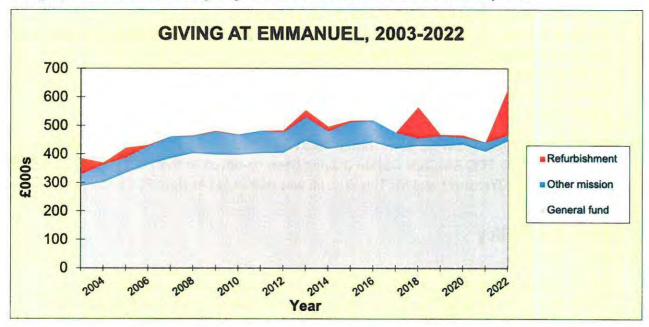
Expenditure was below budget, principally because of underspend by the Property Committee, which will be carried forward to 2023. The overall financial position of Emmanuel central, as shown in Note 2 of the accounts, showed an increase of £4K in unrestricted funds

before property revaluation, after taking into account a transfer of £10K to designated funds to start a fund for replacement of capital equipment and property.

Unrestricted funds at the year-end consisted of net current assets of £211K and property assets of £1.835 million, representing the value of the two clergy houses – 4 Church Close and 64 Chester Road – and the flat at 6 Beeches House, which is classified in the accounts as an investment property, and has been valued at £475K (the same as in 2021), as it is currently let out on the open market. The vicarage is owned by the Diocese of London, although we are responsible for interior decoration.

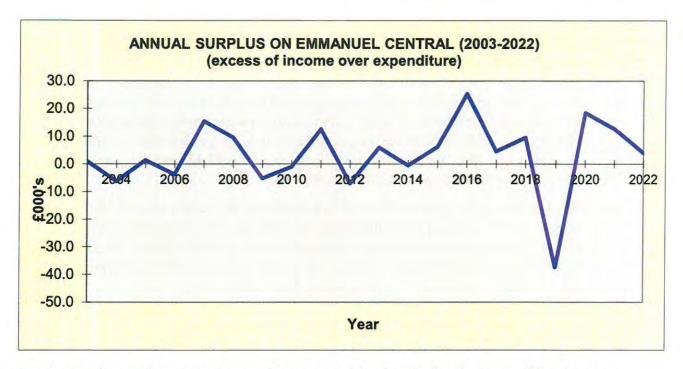
Unrestricted giving (including unrestricted legacies) to Emmanuel central in 2022 rose to £448K (from £410K in 2021), including tax recoveries of £80K.





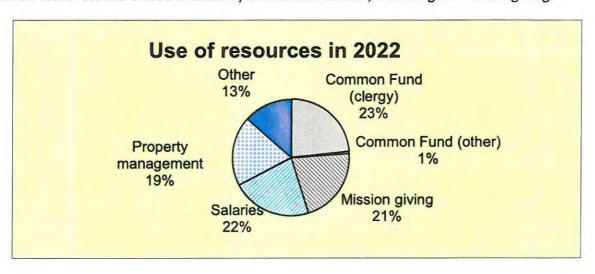
A project was initiated to respond to the recommendations in the most recent Quinquennial Review of the church buildings by having the tiling replaced on the north-facing main roof and repairs to brickwork, windows, sills and guttering. The work was expected to cost around £225K, depending on whether battens and felting under the tiles needed replacing. A contract was entered into with builders Lusso in May 2022. A Gift Day for the project raised £172K. With additional works subsequently decided to be included in the works, the total cost is now expected to be around £235K, with the balance not covered by specific giving being drawn down from designated funds.

The graph below shows the annual surplus (or deficit) each year since 2003 on Emmanuel central (leaving aside revaluations of fixed assets). This averages out at a surplus of £3K a year.



Total expenditure of Emmanuel central unrestricted (and excluding designated) funds rose to £497K in 2022 (£434K in 2021). In addition, £185K was spent from restricted funds (£36.4K in 2021), of which £17K related to mission giving outside of Emmanuel, £4K to grants from the Compassion Fund, £3K to reimbursement of clergy expenses out of the Pratt Bequest and £161K related to refurbishment costs. The balance of designated funds now stands at £92K.

Some 24% of Emmanuel Central total expenditure (£132K) went to the diocesan Common Fund¹ and 21% of total expenditure (£117K) was used for support of Emmanuel mission partners and other mission giving outside the budget. The remaining expenditure is split between ministry, premises and administration costs. The pie chart below shows the way in which resources were used in 2022 by Emmanuel Central, including all mission giving.

¹ Emmanuel's contribution to Common Fund in 2022 was £132,000, of which around £128,710 was the deemed cost of our own clergy. The remaining £3,290 represented our contribution to the financing of other churches in the diocese.

Mission partners and mission societies are supported out of amounts budgeted by the PCC from the general fund. The mission partner budget is allocated by the International Mission Committee. Further information is given in Note 12 to the accounts. In addition to these planned gifts to missions and other charities, church members may make gifts to the Donations Account for other charitable purposes. The Donations Account is maintained with separate bank and deposit accounts, and all resources given for specific purposes are treated as restricted funds to be utilised for those purposes and are not available for other use. A separate report for 2022 by the Donations Treasurer is available, showing details of the allocation of the budget and of other restricted giving.

The PCC have set the budget for 2023 at £499K (£493K in 2022), excluding the Associate Vicar's stipend which has up to now been paid by Eastbury. This would give a surplus of £4K on the basis of income from giving remaining at the same level as in 2022. The expenditure includes carry forward of the cash underspend in 2022 on property maintenance and an allocation of a further £10K to the capital replacement fund.

With 306 individuals on the electoral roll, meeting the budget for 2023 (offset by other non-donation income such as rentals and lettings) would require about £122 per member per month on average. In 2022 there were approximately 156 regular contributors to the FWO, many of whom represent couples, from whom we received an average contribution of almost £236 a month (including associated tax recoveries). That level of giving will need to increase in order to replace income already lost if we are to cover our budgeted costs in 2023. It is also relevant to note that the distribution of gifts is very skew and a relatively modest number of generous givers provide a large proportion of the income.

The PCC continues to exercise careful stewardship in respect of general fund expenditure but believes that budgets in future years should be set to reflect the strategic vision for the parish and also to enable us to maintain the properties for which we are responsible. The Finance Committee continues to encourage the clergy to preach on a systematic basis about the need to submit our personal finances to the Lord and to encourage church members regularly to review their giving. This will be particularly important in the current year, when the budget looks quite challenging. We remain confident that God is faithful and will provide the resources to finance his work in Northwood and beyond.

Notes to the Financial Statements for the year ended 31 December 2022

1 ACCOUNTING POLICIES

1.1 Basis of preparing the financial statements:

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared under the Church Accounting Regulations 2006 in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011.

The Church constitutes a public benefit entity as defined by FRS 102. The financial statements have been prepared under the historical cost convention except for investment assets which are shown at fair value.

There are no material uncertainties about the charity's ability to continue. In these circumstances the financial statements have been prepared on a going concern basis.

Funds

1.2 Unrestricted Funds are funds at the discretion of the PCC that can be used as the PCC decides. Funds for which the PCC has delegated day to day responsibility to the Eastbury Church leadership team are included here, although shown separately in Note 2, and in more detail in Note 11, where further explanation is given of the respective accountabilities.

Designated Funds are funds which were available for use at the discretion of the PCC but where the PCC has formally designated them for particular purposes.

Restricted Funds are funds given for a specific purpose and can only be used for that purpose. The Restricted Funds are the Mission Fund, the Compassion Fund, the Pratt Bequest Fund and the Refurbishment Fund. Further details are given in Notes 5, 7, 12 and 13. A separate report is published by the Donations Treasurer giving details of grants made from the Mission Fund.

Endowment Funds are funds where the income may be used but not the capital. They can be restricted or unrestricted. Information about the endowment fund (the Missionary Training Fund), is given in Note 9. The Pratt Bequest Fund was released from being permanent endowment by the Charity Commission on 8 July 2019 and is now treated as a Restricted Fund.

Income and endowments

- 1.3 All income is recognised in the Statement of Financial Activities once the PCC has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.
- 1.4 Collections are recognised when received by or on behalf of the PCC. Planned giving receivable under Gift Aid is recognised when received. Giving through Charities Aid Foundation and similar trusts is recognised when vouchers received by Emmanuel are submitted to the trusts for payment or, for direct donations to other trusts, when those are transferred to the church.
- 1.5 Gifts to the General Fund for specific purposes are held to be used for those purposes only. Gifts for specified mission, the Compassion Fund or other charitable purposes are held in the Mission or Compassion Fund, all of the assets of which are regarded as owed to people and organisations outside Emmanuel. Gifts specifically for refurbishment are held exclusively in the restricted Refurbishment Fund.
- 1.6 Income from the Coffee Shop and Bookstall is accounted for gross, and is shown as income and endowments from church activities. Expenditure is shown as expenditure on raising funds.
- 1.7 Income of Eastbury Community Church has been consolidated into the respective income categories for the Unrestricted and Mission Funds in the Statement of Financial Activities, although shown separately in Notes 2 and 11. Expenditure is shown under the appropriate category.
- 1.8 The income of Wednesday Fellowship and Baby and Toddler Club is shown as income and endowments from church activities and the corresponding expenditure as church activities.
- 1.9 Interest and dividends are accounted for when credited. Realised gains and losses are recognised when investments are sold.

 Unrealised gains or losses on the Endowment and Restricted Funds are accounted for on revaluation of the investments as at 31 December.
- 1.10 Rental income from letting church premises is recognised when due. Income from letting church houses is treated as investment income.

Expenditure

- 1.11 Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the PCC to that expenditure; it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be directly attributed to particular headings, they have been allocated to activities on a basis consistent with the use of resources.
- 1.12 The Diocese of London Common Fund is accounted for over the periods for which it is due. Any amount for the year which remains unpaid at 31 December is shown as a creditor in the Balance Sheet and any overpayment as a prepayment for the following year.
- 1.13 Grants payable are charged in the year when the offer is made except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled. Grants offered subject to conditions which have not been met at the year-end are noted as a commitment, but not accrued as expenditure. Grants to mission partners and societies which have been budgeted for out of the General Fund are accounted as accruing over the year.

Fixed assets

- 1.14 Consecrated land and buildings and moveable church furnishings have been excluded from these financial statements by virtue of section 10(2) of the Charities Act 2011. Moveable church furnishings are listed in the church's inventory (terrier), which can be inspected in the Parish Office.
- 1.15 Costs of refurbishment and development of the church and its associated buildings have been included as expenditure of the restricted or designated Refurbishment Fund and have been written off in the year.
- 1.16 All expenditure incurred in the year on items of general fund capital expenditure under £5,000 is written off as incurred.

- 1.17 Equipment with a purchase price of £5,000 or more (other than items purchased from Restricted and Designated Funds) is depreciated on a straight line basis over periods as follows: Fixtures, fittings and equipment 5 years
- 1.18 The freehold properties are shown at fair value. It is the church's policy to professionally revalue the freehold properties with sufficient regularity to ensure the carrying value does not differ materially from the fair value at the end of the reporting period. No depreciation is provided on freehold properties, as it is the PCC's policy to maintain these assets in a continual state of sound repair. The useful economic life of these assets is so long that any depreciation would not be material. In addition, these assets will be subject to annual impairment reviews. Provision will be made if there has been any permanent diminution in value.
- 1.19 Deposits include amounts held on deposit at Barclays Bank and CBF Church of England Deposit Funds with CCLA.

Pratt Bequest

The Pratt Bequest Fund is invested in the CBF Church of England Fixed Interest Securities Fund with CCLA. With the approval of the Charity Commission this is now regarded as expendable endowment and is treated as a restricted fund rather than endowment. The capital of 12,750 shares, with market value of £17,480 on 31 December 2022 (23,610 for 14,910 shares on 31 December 2021), will be gradually reduced. The capital withdrawn (£3,000 in 2022) as well as the income (£548 in 2022; £726 in 2021) is used towards the reimbursement of personal expenses of the clergy.

Missionary Training Fund

The Missionary Training Fund is invested in the CBF Church of England Investment Fund with CCLA. On 31 December 2022 capital of 4663 shares was held, with market value of £96,344 (£109,199 on 31 December 2021). The capital is retained intact and the income of £2,865 (£2,771 in 2021) is used to provide assistance to individuals engaging in short-term service overseas or in the UK, or to assist those thinking towards mission service to test their vocation and calling. Following advice from the Diocese of London's Trust Department, the 4663 shares representing the Missionary Training Fund endowment were transferred into the name of the London Diocesan Fund on 22 January 2019 and are now held by the LDF on behalf of the PCC of Emmanuel Church Northwood, with the dividend income being remitted to us.

Financial control:

Eastbury Subgroup of Emmanuel PCC

The PCC Treasurer is accountable to the PCC and to the Synod and Officers of the Diocese of London for the finances of Eastbury The Eastbury Subgroup has delegated authority from the PCC and the PCC Treasurer for the sound and prudent management of the financial affairs of the church. Eastbury Church is effectively autonomous in terms of day-to-day financial decisions and does not have to seek approval from the PCC or the PCC Treasurer to make purchases or commit funds from the resources they control. The financial transactions of Eastbury are consolidated into the annual financial statements of Emmanuel Church PCC and are subject to examination by the Emmanuel Church PCC Independent Examiner. Although Eastbury is expected to be financially self-supporting, their finances are underwritten by Emmanuel Church PCC.

Most donations to Eastbury are made through the Eastbury Church Northwood Trust, a separate charity, and any tax recovered is included in the figure for income from donors.

12 DONATIONS ACCOUNT

The Donations Account (Treasurer: Margaret Dolling) is used to channel giving to Emmanuel's mission partners at home and abroad, and to support mission societies and other agencies engaged in service, relief and evangelism. In 2022 the PCC budgeted £97.5K for the support of Emmanuel mission partners and agencies. 15 TRUSTEE REMUNERATION, RELATED PARTY AND OTHER TRANSACTIONS

The clergy, who receive their remuneration from the Church Commissioners and not from the PCC, received reimbursement of approved expenses from the PCC (or from Eastbury). In the case of the Vicar, Associate Vicar Dave Scott and Curate Christine Britton accommodation was also provided by the PCC at no charge. In the case of Associate Vicar Nina Oskarsdottir accommodation was provided by Eastbury Church Northwood Trust at no charge.

The total amount of expenses reimbursed to the clergy in 2022 was £4,598 (2021: £9,216)

No other PCC members received remuneration or repayment of expenses (other than reimbursement of minor amounts expended on behalf of the PCC or church organisations), with the exception of the following:

The wife of a PCC member is the Administrator. The PCC member concerned does not play any part in the decision-making regarding employment or staff remuneration.

Donations made by trustees during the year amounted to £168K before tax recovery (£121K in 2021).

Report of the Donations Treasurer to the Annual Parochial Church Meeting, 14 May 2023

This report covers all gifts made through Emmanuel in 2022 for mission causes and special projects, principally outside Emmanuel itself, particularly support for our mission partners.

Budget for 2022

The mission budget for 2022 was set at £97,500, covering all those individuals and agencies we planned to support from general church giving throughout the year. While it is intended to be about 20 per cent of Emmanuel's income, the specific annual budget was set by the PCC and reflected unused income in recent years because of Covid restrictions on some activities.

Income in 2022

Total gift income for the year was £103,800, following £97,500 in 2021.

The full budget support for our mission partners from the General Fund was fully utilised by the end of the year. There were some substantial specific individual gifts designated for external mission – in total £6,400 - with particular support for missions linked to the work of our Mission Partners, including support for Jeremy Nash's work with schools in Burkina Faso.

As in the previous two years, the totals received at Emmanuel in special collections at harvest time and Christmas were small because donors were encouraged to send their gifts direct to the recipient organisations using online banking if possible. With the reduction in local bank branches it has become increasingly difficult to process cash and cheques at Emmanuel. The total received in special church collections, including memorial services, for external causes was less than £500.

There were several donations, totalling over £3,700, received for Emmanuel's Compassion Fund and related support needs in the parish. These included £1,500 received for the foodbank from the local Scout group's sponsored "sleepout" to raise awareness of homelessness and hardship.

Much of the other giving to Emmanuel in 2022, unrelated to mission support, was specifically for the roof repairs and other renovation work necessary for our own church buildings. That is not covered in this report.

Investment income for mission use increased in 2022 following investment of the Dobbs legacy in the CCLA Investment Fund. The capital is expected to be drawn down gradually in coming years to finance mission partners and projects outside the parish. Interest receipts also rose following the receipt in 2021 of the legacy from the late Herbert Hackett as well as some improvement in interest rates.

How gifts were allocated in 2022

Gifts which are allocated to specific causes by the donors are always given to those causes in full. Where relevant, income tax recovered on gifts is also included. The recipients are listed in following tables.

In 2022 the major mission recipients for whom we budgeted continued to be Operation Mobilisation (OM) - for Steve and Sandie Davies as well as other worldwide work, including the OM Ships ministry; Wycliffe Bible Translators - for the Morgans, with a reduced level of support continuing for Sharon after David's retirement, and for Kate and Phil King; Arab World Ministries (AWM) - for Tina Salom; Fiona Bunford working at the Montgomery Heights Christian Care Centre in Zimbabwe; the London City Mission in recognition of the needs in London as well as their training provided at Emmanuel; Mark and Alex Ronalds - at Hebron School in India; Interserve Trust Urban Vision – for Tim and Sung Hee Keene, including continued help following Tim's serious illness almost immediately after retiring; and the Church Pastoral Aid Society (CPAS) - which supports outreach in this country.

No grants were made from the income from the Missionary Training Fund in 2022. It continued to be impractical for any of the income to be used to help fund overseas mission visits, all of which had been postponed.

£1,800 was given for the work of our mission partner Fiona Bunford and her colleagues at the Montgomery Heights Christian Care Centre, Zimbabwe

As noted above, donations handled by the church at harvest and Christmas were unusually small. The harvest offerings were for TEAR Fund's "Forgotten Crises" Appeal and Emmanuel handled only £30 for that. Those at Christmas raised £375 for the OM Ukraine in Crisis Appeal and Watford New Hope Trust.

What is happening in 2023?

The mission budget for 2023 to be financed from Emmanuel's General Fund has been set provisionally at £93,700, somewhat lower than for 2022, reflecting in part the retirement of some mission partners and likely changes in employment roles of others. The proposed allocation has been presented to the PCC. It is to be hoped that the unrealised mission projects envisaged for recent years, especially those involving young people, will be able to progress within the next year or two, making use of income generated by the Missionary Training Fund.

FABRIC, GOODS and ORNAMENTS REPORT.

The property Committee works to ensure that the church buildings, fabric and ornaments remain in good order. A formal report to the APCM is delivered each year. The Chair is Mr Neil Altman. As well as overseeing the maintenance of the Church buildings the Property Committee oversees the vicarage (which is owned by the Diocese of London and who are responsible for the fabric of the building) and the following properties owned by the PCC:

- 64 Chester Road which is lived in by the Revd Christine Britton and her family.
- 4 Church Close which is lived in by the Revd Dave Scott and family.
- Flat 6 Beeches House, High Street rented commercially.

All gas boilers in the church buildings and the above properties were gas safety tested and serviced.

Health and Safety remains a priority and no incidents were reported.

The following work has been undertaken to the Church site:

A comprehensive PAT testing of relevant electrical appliances was undertaken.

The Fire detection and alarm system has been serviced.

TESTING.

The temperature of all hot and cold running water is tested to protect against Legionnaires disease. The emergency Fire Lighting is tested and fittings replaced where faulty. The Fire Alarm is routinely tested.

MAJOR BUILDING WORKS PROJECT.

Following on from the Church Family's amazing generosity and our God's wonderful provision we have been able to carry out a large proportion of the works which were listed in the 2018 Quinquennial Inspection (QI) as essential within five years. Additionally, we have also been able to replace the failing tiles on the North Pitch of the Church roof. A full schedule of works is available upon request but includes the replacement of over one thousand bricks which were suffering from spalling, the replacement of areas of defective church glazing and guttering

IMPENDING WORKS.

We have instructed our surveyor to undertake our 2023 QI. Being custodians of an elderly Church buildings require continual maintenance and we have written a five-year plan of proposed upkeep.

The Committee is also involved in the possible works to the Westgate and former Toy Library areas

Planned works this year include

- 1)External decoration to Hall Windows, Hall Entrance and Main Reception area.
- 2) Replacement of Lounge Carpet with hard flooring and acoustic improvements
- 3) Replacement of office carpets and the stair carpets

THE HARROW DEANERY SYNOD

ANGLICAN CHURCHES IN HARROW AND NORTHWOOD

REPORT FOR 2022

ANNUAL REPORT FOR 2022

The first meeting was held on 23 February at Christ Church Roxeth. Revd Elaine Weaver shared information about the parish and led the opening worship. Emmanuel Gill spoke about the purpose and work of the London City Mission in Harrow. They work alongside teams from the churches to reach out to the Hindu and Muslim populations. The Area Dean introduced a discussion on the focus of the Deanery Synod to assist the Standing Committee with the choice of subjects for future meetings

A service to welcome Bishop Lusa Nsenga-Ngoy to the Willesden Area was held at Emmanuel Church Northwood on 27 February. A Deanery Eucharist celebrated by Bishop Lusa was held in Holy Trinity Church Northwood on 7 June. The service was followed by a time of Fellowship when members of the churches could meet Bishop Lusa informally over refreshments.

A meeting to discuss Synod business was held using the Zoom software on 6 July. One application for a grant from the Deanery Mission Fund had been received from St Peter's West Harrow for £1,000 towards their work with young people; this was approved. The Deanery Accounts for 2021 were received and approved, subject to Independent Examination. Revd Emma Webber was elected to the vacancy for a clergy representative on the Deanery Standing Committee. Pam Clissold was standing down as Deanery Treasurer and it was agreed that Revd David Green would act as Treasurer until an election is held in July 2023.

The third meeting was held on 10 November at St John's Church of England School, Stanmore. The school choir welcomed Synod to the school by singing some songs. Jo Hester, Headteacher, gave an introduction to the school and the pupil composition. She explained the school's ethos and vision, and that it is recognised as a Music Hub, Early Years Hub and Religious Education Hub. The music teacher explained that the school orchestra had over 50 members and there were choirs from both sections of the school The Assistant Headteacher explained the curriculum and the main drivers. Four of the children shared their experiences at the school. The choir sang their vision song including the words "we make a difference".

Becky Frost and Hilary Millard from *Harrow Re:generation* shared the resources that they provide to churches and schools in Harrow and their involvement during the year. They asked for continuing support from the churches for their work as a charity including volunteering, financial giving and prayer.

James Wood and Helen Wolstencroft shared information about the Church of England Growth Report in respect of young people and the changes that churches need to make as a result of the pandemic. They explained that churches, some of whom do not have the volunteers for youth work that they had previously, need to partner with other churches and organisations and use the resources available from the Diocese. There was then a time for prayer in small groups. The 2021 Deanery Accounts had been Independently Examined successfully.

Monthly Prayer for Harrow has taken place on the first evening of each month under the leadership of Revd Malcolm Finlay and then Revd Ian Dowsett, using the Zoom software.

Reports on the sessions of the London Diocesan Synod and of the General Synod were received at meetings during the year.

Report on Safeguarding at ECN for the APCM in April 2023 Introduction

At Emmanuel Church Northwood safeguarding practice has continued to evolve through the post pandemic season, despite the challenges of working with our very overstretched and unfunded partners of the NHS and social care. Indeed, in the current context of economic struggles and a lack of community care it is even more important that we continue to proactively practise our duty of care to all those we come into contact with, but especially children, young people and vulnerable adults.

Feedback from staff, church leaders and members, outside agencies such as the police, social care and our Diocesan safeguarding advisor, and from the people who come to us for help, continues to confirm that safeguarding is a consistent strength running through all our church and pastoral activities. Moreover, those leaders within the ECN community who have undertaken training either through the Church of England online or through an 'in house' online or face to face session have also reported that this has equipped them with the knowledge of at least how to seek help, when faced with a disclosure or having to raise a concern.

Concerns reported and referrals made

Over the last year we have received a steady stream of safeguarding concerns and are now back to our pre- pandemic levels of, on average, one concern a month being reported to the safeguarding team at ECN. These are often in relation to a historical rather than contemporaneous issue and are mainly focused on vulnerable adults, some of whom remain outside the church but use an associated service such as foodbank. Often in these cases, there has been prior involvement from other agencies such as the police and social care. Most cases simply require the safeguarding team to keep a watching brief, build relationships and signpost where we can and try to ensure that other agencies follow up were concerns persist and referral has to be made.

All concerns logged over the last year have been submitted electronically on the appropriate form. Concern forms are completed carefully, often give a great deal of background information and are generally objective and factual. This makes the safeguarding team's work of assessing concerns and knowing when to refer them on easier and is a reflection of the church community's commitment to getting this right in practice. A culture of transparency and a shared corporate understanding that regrettably our community is not immune to abuse, have proved essential tools which enable us to better meet pastoral needs in a relevant way.

Commitment to the Diocese of London's Safeguarding Policy and practice

Over the last year at ECN and Eastbury, we have continued to comply with the Safeguarding and Clergy Discipline Measure 2016 and we have endeavoured to fulfil the requirements of the Diocese of London's Safeguarding Policy and practice as outlined below:

'Safer churches' – a key priority for our 2030 vision

Welcoming everyone into the life of the diocese, into a community where the value and dignity of everyone is valued and respected is not only core to the Gospel and our calling, but to safeguarding. Everyone should know that they are as safe as they can be and that safeguarding is an integral part of our life and ministry.

Safeguarding and the development of safer churches is everyone's responsibility

The care and protection of children, young people and adults who may be vulnerable, and who are involved in church and other activities within the diocese is the responsibility of the whole church and everyone who participates in the life of the church and diocese has a role to play.'

Training in 2022-23

- A face to face safeguarding training presentation was delivered to the whole PCC in June 2022
- Our annual sessions of in house safeguarding were once again delivered face to face in October 2022 to groups of leaders. We also videoed these sessions for those who were unable to attend in person.
- Leaders and members of the congregation have continued to access the Church of England online safeguarding training.
- For the first time the Leadership of ECN have set an expectation that anyone working in a leadership
 capacity in our church must complete the Church of England online training and ideally attend in
 house as well, especially if you work with children, young people or vulnerable adults. In May 2022
 we asked the whole PCC to complete this training and everyone has. A real achievement and a big
 change from five years ago.

The in house training sessions use scenarios to get people to actively consider what they would do to address a safeguarding situation in practice. This has supported the development of church wide confidence and expertise. A blended model of in person and online training, sets a realistic context and outlines general safeguarding principles and best practice applicable across the whole of society, not just within the Church of England or Emmanuel Northwood. This has proved particularly successful as it reminds team members and volunteers that we don't have to face safeguarding concerns alone, but within the context of a supportive team and structured procedural framework

Policies- our ECN safeguarding policy is reviewed and ratified by the PCC in spring each year, the most recent version being agreed in March 2023. It is based on the revised safeguarding policy issued by the Diocese of London in October 2018 and is compliant with recent statutory guidance. We continue to also adopt the Church of England's Parish Safeguarding Handbook, published in October 2018. Both of these documents are available on our ECN website, along with our strategy for safeguarding, which prefaces our policy, a number of appendices, case studies and other useful resources.

Further actions to be completed include the ongoing completion of the Parish Dashboard which has superseded the annual safeguarding audit to the diocese, which takes considerable time to keep up to date online; the Parish Safeguarding Officer's contributions to the ECN risk register and updates to various policies. We also compile an annual schedule of safeguarding tasks and paperwork reviews, to ensure training, policies and procedures are consistently updated in line with current best practice and changes in statutory guidance.

Disclosures and Barring Service Procedures - From January 2022 the Church of England has required all DBS clearances for all staff and volunteers to be updated every three years, instead of every five years as was the previous recommendation. to get all our DBS clearances on to the new more frequent cycle. Thanks are due to Jean Nunney and Jon Whitmarsh who have worked very hard to get all our DBS clearances on to the new schedule.

Last year, we reviewed our process for recruiting and vetting volunteers to ensure it would not allow anyone to begin working without DBS clearance and two satisfactory references. We also require volunteers to sign a volunteer agreement form which makes a commitment to undertake annual safeguarding refresher training. Tim, as vicar, is also required to agree the appointment of any volunteer in advance and I check all the references and highlight any concerns to him before any volunteer commences work. All references and training attendance records are filed electronically on a secure drive on our server.

One possible next step is the transfer of any paper records held in the church office, whether historical safeguarding concerns or references, into electronic format.

Conclusion

ECN as a community has developed considerably and continues to evolve, in terms of our understanding of safeguarding, the potential risks it poses and how we can best mitigate and manage these. That the training sessions have engendered collaboration, genuine transparency, leadership learning and laughter, has been an unexpected but very welcome gift.
